1. Update to key milestone date:

2. Remove Section 00320 Bid Form – Addendum 2, pages 40 and 41 and replace with revised Section 00320 Bid Form – Addendum 4 pages 40 and 41, attached to this Addendum.
3. What size is the CCR#9 for TW C East and TW V South? 4KW, 10KW, 7.5KW, 20KW or 30KW? 3 or 5 Step? Is the 4KW CCR for 16-34 RGL 240V and a 5 Step? *Detail A1 on EL603 contains CCR schedule and answers the above questions. Clarification: The total combined proposed load for the TW C(East) & TW V (South) circuit is 5.75kW. This information will be updated in detail A1/EL603 in the Issued For Construction set.*
